Please read the following instructions carefully. Registration is possible through [www.dogoffice.cz](http://www.dogoffice.cz) online system only. Applications sent by post will not be accepted. For the registration, it is necessary to create an account in the online system. In the next step, you can add your dog's profile in MY DOGS section and fill in all the information. In DOCUMENTS section, a legible copy of both sides of the pedigree must be uploaded for each dog. The pedigree must include legible details of the owner. In DOCUMENTS section, you should also add certificates or champion certificates in case you plan to entry your dog into working or winner class.

After the registration, you will receive an email with the confirmation and you will be able to see the application in MY APPLICATIONS section. After the registration is complete, the system will generate variable symbol for the payment. The application is valid only after the payment has been completed. If you do not receive the confirmation email, registration has not been completed. In that case, please contact us immediately at [canecorsoklub@email.cz](mailto:canecorsoklub@email.cz).

The organiser has the right to decline a dog's application to the show without giving a reason. Exceptions are possible only with the organiser's approval. By sending the application, participant agrees to follow all the FCI and ČMKU regulations as well as the show's propositions.

Entry of one dog into more classes, application cancellation or applications submitted after the second deadline will not be accepted. The change of class or class entry cancellation is not permitted. Admission to a respective class is determined by the age of the dog on the day of the show (i.e. on the day of the judging of the dog at the show). Entry forms will be available in your account at [www.dogoffice.cz](http://www.dogoffice.cz) before the show.

To enter a dog in working class, a copy of the certificate of a successful completion of the working test must be uploaded to the [www.dogoffice.cz](http://www.dogoffice.cz) system. To enter a dog in winner class, a copy of one of the following titles must be uploaded to the [www.dogoffice.cz](http://www.dogoffice.cz) system: International Champion, National Champion of one of the FCI member countries, National Winner, Club Winner, Winner of Specialty Dog Show, World Winner or European Winner (the title must be obtained in Intermediate Class, Open Class, Working Class, Winner Class or Champion Class). In case there will be no attachments enclosed, the dog will be automatically entered into Open Class.

**Classes:** Dogs are divided in classes according to the ČMKU and FCI regulations: Minor Puppy Class, Puppy Class, Junior Class, Intermediate Class, Open Class, Working Class, Winner Class and Veteran Class.

**Titles:** Club Winner - dog, Club Winner - bitch, Young Club Winner - dog, Young Club Winner - bitch, Veteran Club Winner - dog, Veteran Club Winner - bitch, Puppy Club Winner - dog, Puppy Club Winner - bitch, Minor puppy Club Winner - dog, Minor puppy Club Winner – bitch.

CAJC, BOJ, CAC, Res. CAC, BOB, BOS, BOV,  
Title awarding is not demandable.

The organiser has the right to change the judge.

### **Veterinary Regulations**

All dogs must be clinically healthy. Dogs must have a valid pet passport or certificate of vaccination and must have a valid vaccination against rabies as stated by the law.

Dogs from the EU and third countries must meet the conditions given by the EU Regulation n. 576/2013 from 12 June 2013. Veterinary regulations of the Czech Republic and the EU will be in place during the whole duration of the show for all participants.

## General Regulations

The show is held under the ČMKU and FCI regulations and is accessible to all males and females of the cane corso breed who reach the age required for entering the respective class on the day of the show at the latest. All the dogs are judged according to the ČMKU and FCI regulations. Sick dogs, nursing females, females in heat, females in later stages of pregnancy or dogs with cropped ears are not permitted to attend the show.

Exhibitors are responsible for the welfare of their dogs. It is strictly forbidden to expose the dogs to situations which may compromise their health or well-being, such as leaving the dog unattended in a car during hot or cold weather or treat them in an aggressive or unkind manner. **The use of retractable collars without a stop is prohibited.** Breaking the above stated regulations will lead to expulsion from the show without the right to claim the registration fee refund.

All dogs must be on a leash. Free movement of dogs is not permitted. Throughout the duration of the show, the owner must have their dogs under control and is fully responsible for all the damages towards other dogs, people or property of the organiser. The organiser is not responsible for any injuries nor death of dogs. Changes in dog's exterior are forbidden.

In case of the show cancellation due to unforeseen circumstances, the fees will be used to cover the show's expenses.

A protest against any decision made by a judge (awards, position ranks and titles) is not acceptable. A protest for formal reasons (violation of the ČMKU regulations or propositions of this show) is acceptable. The protest must be submitted in written form to the show committee against a deposit of 40 EUR. Should the protest be declined, the deposit goes to the organiser of the show. Protest can only be submitted during the course of the show. Protest submitted after the show is not acceptable.

Exhibitors agree with publication of their personal data on the club website, in the club yearbook and in the show catalogue. Catalogue in digital form will be sent to the email stated in the application on the first day of the show at the latest.

## WARNING

Photo and video footage might be taken during the show. By attending the show, participants and visitors agree with the possibility of being recorded and photographed. If they wish otherwise, they must notify the photographer directly. Presenting the puppies in order to offer them for sale at the show is forbidden. The change of the judge is possible.

Exhibitors should be aware of the possibility of random identity checks of dogs at any point during the course of the show. We recommend that the exhibitors check the readability of tattoos or microchips beforehand. Exhibitors are required to present the pedigree of their dogs on demand in order to have the tattoo number or microchip checked, as well as the certificate of vaccination.
